

## **CITY LIMOUSINE MILANO**

### **PRIVACY POLICY**

Pursuant to article 13 of Lgs. Decree 196/2003 concerning the protection of personal data.

This is to inform all the visitors of our website [www.citylimousinemilano.it](http://www.citylimousinemilano.it) of our policy concerning the handling and processing of our customers' personal data.

CITY LIMOUSINE MILANO is firmly committed to dealing and protecting Your privacy and states that this privacy policy conforms to the above law.

Surfing our site is free and you don't need to register with the exception of some areas where you can freely and specifically provide Your personal data to access specific services You may request. If therefore the visitor chooses to provide His/Her personal data to access these further services, S/He will be informed, as required by the D.Lgs 30 June 2003, n° 196 (law concerning the protection of personal data) about the use and purposes of Your data by City Limousine Milano and about Your rights of cancellation of Your data, which You may always exercise, as provided for by article 7 of the Code.

#### *Information about personal data protection*

Pursuant to article 13 of Lgs. Decree 196/2003 concerning the protection of personal data, City Limousine Milano provides the following information.

#### **1. DATA PROCESSOR**

The data Processor is City Limousine Milano, based in Settala (MI), Via Leonilde Nilde lotti, 14 postal code 20090.

#### **2. TYPES OF PERSONAL DATA PROCESSED**

To access our website You don't need any registration. However, there are some services that can be obtained only on providing Your personal data, specifically Your data may be requested to get a quotation or to contact us.

Anytime we acquire information and personal data, City Limousine Milano will inform the users, as required by the D.Lgs 30 June 2003, n° 196, about the reasons why these data are required and the methods they will be processed. If necessary City Limousine Milano will ask the user's consent to use the same data. For example, we may require some personal data such as name, surname, telephone number, e-mail address and the information that the user will have to provide to use some services, and have access to some reserved areas in the site, following a registration form.

City Limousine Milano will use these data only as established, for example to send a quotation if it has been asked.

#### **3. OPTIONAL SUBMITTAL OF PERSONAL DATA**

The submittal of personal data is not compulsory; however, these are necessary to access some specific services and receive what asked for.

All data concerning connecting and surfing our site (e.g. the IP address of our visitors' personal computers) will be stored and processed anonymously and only for statistic aims and then they will be erased.

#### 4. DATA HANDLING AND COMMUNICATION

Your data may be processed by electronic means or on hard copy. City Limousine Milano guarantees a correct and legal use of Your personal data received through the site, in compliance with the legal provisions, and the utmost secrecy in the handling of the data recorded. The data will not be transferred to third parties as otherwise decided and authorized by the same user.

#### 5. LINKS WITH OTHER SITES

The present information report is to be applied only to the web City Limousine Milano and not to other sites visited by the user through site links. City Limousine Milano can not be considered responsible for personal data provided to other sites, to external subjects or other sites linked with ours.

#### 6. DATA SUBJECT'S RIGHTS

Pursuant to article 13 of Lgs. Decree 196/2003 You have the right to obtain, by the data Controller, any information about the handling of Your data and in particular

1. data subjects shall have the right to obtain, with no delay, the confirmation of the existence or non existence of personal data which concern themselves;

2. to obtain as well

a) the source of personal data, the purposes and methods of the processing, of the logic applied to the processing, if the latter is carried out with the help of electronic means, of the identification data concerning data controller, data processor and the representative designated, updating, rectification or, where interested therein, integration of data.

b) erasure, anonymization or blocking of data that have been processed unlawfully.

3. to object, in whole or in part, to the processing of personal data, where it is carried out for the purpose of sending advertising material or direct selling or else for the performance of market or commercial surveys.
